She is currently represented by the Antreasian Gallery in Baltimore MD, the Applegate Gallery in Vienna VA and Gallery West in Alexandria VA. Her paintings have been exhibited in thirteen states and the District of Columbia. Jurors have included Philip Pearlstein Jack Beal, Alan Hacklin, Carolyn Day and Trina Schart Hyman. CONDITIONS FOR ENTRY

Artwork submitted must be based on horticultural, natural or local history theme with a limit of 3 pieces of art per person. Work may be no larger than 30x40 inches including frame.

Only hand-painted, hand drawn or other "original" art will be accepted.

Traditional photographs and digitally enhanced photographs will be accepted. Drafts, photocopies, offset prints, lithographs or copies of already published art will not be allowed. 15% of the net proceeds will be donated to the FCPA.

Entries must be ready to hang with hooks and wire.

Saw tooth hooks, wet canvases, soiled, or poorly matted works will not be accepted.

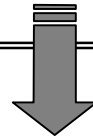
